



**FITTING INSTRUCTIONS FOR LP0034BK TAIL TIDY (LICENCE PLATE HOLDER)
FOR STANDARD INDICATORS**

Kawasaki ZX10-R '04-'05 & Kawasaki ER6



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

- NOTE YOU WILL NEED TO GLUE THE LIGHT SHROUD TO THE LED LICENCE PLATE LIGHT BEFORE FITTING USING SUPER GLUE.
- Remove seat.
- Undo wiring loom to number plate light & flashers. Please note routing and position.
- Undo the 4 nuts holding the tail unit to the bike & remove tail unit.
- Take the R&G licence plate holder & fit to the bike using the 2 rubber spacers and the 4 nyloc nuts supplied & tighten.
- Fit the led number plate light and the indicators. Use rubber gaskets supplied for original indicators. **For imported models, after market indicators or the ER6 you will require our Indicator Adaptors – part number IA0001BK.**
- Reconnect wiring as original routing and position.
- **Note:** we suggest that you cut the plug from your original number plate light and connect it to the LED light supplied using the two splice connectors in the kit.

If you plan to fit mini indicators to the rear of the bike only (not the front), you will need to fit a resistor, in order to reduce the wattage. We recommend the R&G resistor – part number RGR0001.
